#### **Transparency:**

Suppliers are expected to be transparent in their business practices, including financial transactions and disclosure of relevant information.

#### **Fair Competition:**

Suppliers shall compete fairly and ethically in the marketplace, avoiding anti-competitive behaviour and practices such as price-fixing or collusion.

#### **Conflicts of Interest:**

Suppliers should disclose any conflicts of interest that may affect their ability to act in the best interests of our organization.
